From the President



Here it is, the middle of October. The show season is in full swing. If you're like me, you're wishing that those late hatches would grow some feathers so that you would know what you had to work with.

Yesterday I managed to get my birds vaccinated. It's a job I don't enjoy, but due to a very bad experience a few years ago, I know that it is necessary. I brought a bird home from the national a number of years ago that hadn't been vaccinated for PMV and it brought the disease into my loft. I had some rollers that were used as fosters that never left the loft that I hadn't vaccinated. The disease went from the new bird to the fosters to my young helmets in the new breeding season. That wasn't a very good year. Please vaccinate your birds before you show them. You wouldn't want your birds to become infected and you wouldn't want to be the cause of someone else taking the disease home. By now I expect that you've got a couple of hopefuls to show. Good luck to you in the showroom.

You have not seen a ballot for the elections this year. The reason is that there were only a few nominations that came in and as luck would have it, when Chuck contacted those nominated, there was only one nominee for each variety that accepted the nomination. We also only had one nomination for member of the year, therefore the results were automatic. The list should be published elsewhere in this bulletin. I would like to thank each of those who accepted this nomination to judge, and all those who are willing to step up and take a turn judging at any of our shows. We all work hard each year to breed that show champion and I appreciate anyone who will forego showing to give the service of judging our birds. It is often a thankless job. I don't always agree with the way a judge places the birds, but if a judge will give the birds a thorough look over and do his best to judge according to the standard, then I thank him for his efforts. We don't always see what the judge sees up close and personal. I have found many times that a judge has pointed out something to me that I have overlooked and I have learned from it. Thanks to our judges.

It's show time!! Make sure you do your part in preparing and conditioning your bird for the show. He'll do his part. I hate to see an otherwise outstanding helmet get placed down for pin holes or poor condition or because a few foul feathers haven't been removed by his owner. Win or lose, I'm always pleased when I can set down a show team that are prepared as well as possible and look the best they can. It's a beautiful sight.

The full results of the show will be posted on the web site in a few weeks and should appear in our next bulletin. I look forward to seeing everyone at the shows this season.


New AHA Web Site

As you may or may not know, the N.F.L. College Football Draft was recently held. I follow football, and watched as each team picked new players for this season. While this was going on, I started thinking how it would be to own and /or coach a pro team and how it would be to make all the decisions about new player and such. Then, it dawned on me that raising Helmets is a lot like having your own team.

To start with, you are the coach. You pick the team. Starting a <u>Season</u>, you look at your <u>veteran</u> breeders from last season. You look at their performance and see what your goals are. What does your <u>Team</u> lack? Your <u>Rookies</u> are all the young you raised last year. By <u>Cutting</u>, you have gotten down to only a few of the best (which I call my <u>Draft Picks</u>). Are any of these able to break into the <u>Line Up</u>? Can they bump a veteran out and make the <u>Roster</u>? I limit my team to twenty pair so only forty birds can be kept. I do have a <u>Taxi Squad</u> of three extra hens and three extra cocks. I cam use these as feeders, or if I lose a bird, I can put a <u>Taxi Squad</u> member on the <u>Active Roster</u> as a replacement and still maintain a full team.

About the time I have my <u>Roster</u> set, I go to a swap meet or a fellow Helmet Breeder's loft and see that one <u>Free Agent</u> that could <u>Turn the Team Around</u>. This bird has the one thing the team lacks and has possibilities of being a <u>Super Star</u>. It could produce some <u>All Pros</u>. I have to have the bird, so I <u>Try to Sign it</u>. I work hard for a <u>Trade</u>. It costs two red M/F cocks and a <u>Third Round</u> pick from it's first mating.

As the <u>Regular Season</u> comes to a close, it's show time and the <u>Playoffs</u> begin. The local shows decide a lot. You check the <u>Standings</u> and wonder if your team will <u>Go All The Way</u>—The eastern and western Sectionals and National Young Bird Show. Then it's on to the <u>Super Bowl</u>—The N.P.A. Grand National. Maybe, later on, your bird will enter the <u>Hall of Fame</u>.

You're not only the owner of your team, but also the coach. You call the shots. You determine whether you win or lose. You make the <u>Trades</u>, do the <u>Drafting</u>, and decide on the <u>Cuts</u>. You are team trainer. Coop Training and handler are so important. You are also the Team Doctor. Sickness or injuries could keep a bird <u>Out For the Season</u>, and you out of the <u>Playoffs</u>. Be on your toes and watch their health and <u>Training Table Diet</u>. You're also the equipment manager. Judging sticks, coops, carrying cases, waterers, nest bowls, etc. all have to be maintained and kept clean.

All in all, Helmet Breeding and pro Football have a lot in common so, Good Luck to everyone and hope to see many of you in the **Championships!**

Postal Service Seeks to Expand **Live Animal Shipping Opportunities**

The U.S. Postal Service, at the urging of U.S. Senator Grassley (R-lowa), has written FedEx stating that as it appears that FedEx regularly and commonly ships all types of live animals, it can no longer invoke an exception in the law that allows it to refuse to carry live animals as part of its mail service contract. Therefore, the Postal Service has said, "we (Postal Service) expect you (FedEx) to comply with the statute by beginning to carry live animals..." as mail. The letter in particular refers to "day old poultry and such other live animals as postal regulations allow to be transmitted as mail matter."

The Postal Service noted that it has been contacted by a number of customers and their representatives regarding this matter. The AU was one of those representatives that has been raising this issue with the Postal Service.

FedEx had 60 days from receipt of the letter to beginning carrying live animals. As the letter was dated August 26, 2005, this means that FedEx should start carrying live animals by the end of October. If FedEx complies, this should open up many more options for the shipping of pigeons as mail. However, we have not yet heard FedEx's response to this letter from the Postal Service. It is likely that they will fight.
